

2025 District IV 4-H Shooting Sports Contest Memo

Contest Date: April 26, 2025

Contest Location: Rocky Creek Outdoors, Texarkana, USA

4001 South State Line, Texarkana, AR

ALL competitions will take place on ONE (1) day – A detailed schedule to be sent out to participants and agents following close of registration.

Eligibility: Participants MUST be currently enrolled in 4-H through 4-HOnline and pay applicable entry fees for EACH discipline entered. Participants MUST be academically eligible according to UIL rules to compete on the day of the contest.

Novice competitors are welcome, but all shooters MUST be actively involved in a county 4-H shooting sports program prior to competing. Shooters must have received instruction/training on safe firearm handling, safety protocols and general rules of play from a 4-H certified shooting sports coach. 4-H Certified Coaches and Extension Agents will be notified following close of entry to verify shooters are a part of their county shooting sports program.

NEW

The Shooting Sports Coach MUST sign a Verification Form provided by the Agent and District Office indicating the shooter participated in their Shooting Sports Project Meetings, Practices, and Safety Meeting. If they deny the youth participated, then the child will NOT be allowed to compete at the District Contest. NO EXCEPTIONSI

Age Divisions: Junior – 8 years old AND in the 3rd grade through 5th grade

Intermediate – 6th grade through 8th grade
Senior – 9th grade through 12th grade

Registration: Registration will open in 4H Online on March 12, 2025 and close at midnight March 26, 2025. NO late entries – NO exceptions.

NO REFUNDS will be issued except in the event of a rain cancellation by District staff. If there is a rain cancellation, the Rifle Contest, a State Qualifying Event, will move to an indoor range. All other events will be canceled in the event of a rain cancellation.



Registration Options: Participants may select one (1) to three (3) disciplines listed below in which to compete.

1.	Archery	\$40 entry fee
2.	Pistol	\$40 entry fee
3.	Smallbore Rifle	\$40 entry fee
4.	Sporter Air Rifle	\$40 entry fee
5.	Trap	\$40 entry fee
6.	Skeet	\$40 entry fee

Entries Per County: Each county may enter unlimited participants per age division per discipline. Rifle and pistol teams and shotgun squads MUST be designated at time of entry.

REQUIRED Release Forms: Each member must complete and submit the attached release forms at check-in:

- 1. Indemnification and Medical Release Form
- 2. Rocky Creek Outdoors Range Release Form)
- 3. REQUIRED Pistol permission form (keep in pistol case)

Day of Competition:

UPON ARRIVAL:

- 1. **STOP** at MAIN Check-In Table Turn in signed & completed release forms. 4-H members will <u>NOT</u> be allowed to compete if release forms are not turned in at MAIN check-in.
- 2. **GO** to each discipline in which you will be competing to check-in, do an equipment check, review schedule, safety information and receive any updated information.

INFORMATION FOR THE DAY:

- Each participant must furnish their own equipment firearm, ammunition, safety equipment, sandbags (pistol), etc.
- Each participant is responsible for having the proper attire. (see each disciplines information)
- The range is located in a rural area you may want to bring lawn chairs, drinks, snacks, etc.
 Coolers are welcome food trucks are scheduled to be at the facility for lunch. Onsite cooking on grills, etc. will not be permitted.
- SAFETY is paramount. IF a safety issue arises, anyone can call for a cease fire.
- Range officers will be at each range

Participants with Disabilities. Any competitor who requires auxiliary aids or special accommodations must contact the District Extension Office or Denita Young at diyoung@ag.tamu.edu or note when registering on 4-H Online at least 2 weeks before the competition to request such needs.



Range Safety and General Rules:

Disorderly, unsafe, and abusive conduct has no place at the range and will NOT be permitted or tolerated. Individuals who exhibit such conduct may be immediately disqualified and/or dismissed from the grounds. The match director, 4-H Specialist, and/or District Extension Administrator will have final say in all disputes.

Individual contest Safety and Range Rules may be included in the rules for each discipline.

- 1. Hearing and Eye protection must be worn on the pistol, rifle and shotgun ranges at all times. NO electronic "blue tooth" capable devices. Shooters will be asked to leave smart watches, phones, etc. in their bag or with coach/parent/guardian. Shooters may use electronic hearing protection that are NOT "blue tooth" capable.
- 2. ALL Firearms are to remain in the case until given the command to uncase. Open Action or Open Bolt (OBI) Indicators are required for pistol and rifle. Shotgun actions are to remain open and empty until the shooter is on the shooting station. Firearms are to remain unloaded AND cased until instructed by the Range Officer.
- 3. Maintain muzzle awareness at all times! In the event of a misfire keep firearm pointed down range.
- 4. Safe and respectable behavior is expected of shooters, coaches, and spectators at all times.
- 5. NO profanity from shooters, coaches, or spectators.
- 6. NO yelling or running at any time on the range.
- 7. NO alcohol or tobacco this is a violation of Texas 4-H Rules! Adult smokers should do so away from the ranges, participants and spectators.
- 8. Participants under the age of 13 must have an adult present at all times.
- 9. Closed toe shoes, long pants, and shirts with sleeves (short or long NO sleeveless) must be worn on the range.
- 10. Long hair must be pulled back.
- 11. In the event of a severe storm or severe storm warning, a horn will blow three (3) times to signal that all participants must leave the range immediately to take shelter.
- 12. Have FUN!

Shooting Order / Schedule:

The District IV 4-H Shooting Sports committees will meet prior to the contest to set up the shooting order / schedule. Check with your county office a couple of days before the contests to obtain the shooting order / schedule. The schedule will be flexible – do not panic if you are running late for your next discipline.

Arrive early to get checked-in at each of your disciplines for equipment check and to let the officials know you are here. If there is an open spot to shoot, you could shoot early. IF you are competing in multiple disciplines and you see you will be running late or close for the next discipline, have someone let the officials at the next contest know you will be late. We will work with you as long as we know you are working with us.



Awards:

Awards will be presented approximately 45 minutes to 1 hour following completion of last round of shooters at each range. If you cannot stay for the awards presentation, your awards will be given to your County Agent.

- Buckles will be awarded to high individual in each age division in each discipline.
- Ribbons will be presented to 2nd through 5th high individuals in each age division in each discipline
- Banners will be presented to the top three (3) individuals for overall shotgun (trap & skeet scores combined
- Awards will be presented to the top three (3) teams in small bore rifle and sporter air rifle in each age division.
- Awards will be presented to the top three (3) teams in pistol in each age division.

KNOWLEDGE OF THE MATCH: While we want full participation from all counties in District IV, many of our shooters are beginners, Range Safety is PARAMOUNT. We are pressed for time in nearly all events. Formal competition is NOT an instructional training period. It is essential that all shooters and coaches understand the rules, event procedures, line commands and possess the basic skills in each discipline in which they are to shoot. IF you are not sure of what the rules are saying or don't know – please contact your County 4-H or ANR Agent for clarification.

Indoor Rifle Match

Thank you in advance for your cooperation and understanding in helping us provide safe, quality contest opportunity for your child.

Archery Rules – Non-Qualifying Contest

Following the completion of the contest, participants are to remain with their shooting group and turn in their official score cards to the Range Aide nearest their last target AS A GROUP. Individuals leaving the range with their official score card or not turning them in to the Range Aide with their group are subject to disqualification.

Course of Fire:

- 1. 20 3-D targets
 - a. JUNIORS will shoot a total of 20 targets at a maximum distance of 20 yards; Junior Genesis will shoot a maximum distance of 10 yards
 - b. INTERMEDIATES will shoot a total of 20 targets at a maximum distance 25 yards; Intermediate Genesis will shoot a maximum distance of 15 yards
 - c. SENIORS will shoot a total of 20 targets at a maximum distance 30 yards; Senior Genesis will shoot a maximum distance of 15 yards
- 2. 1 shot at each target
- 3. Each station will have colored markers based on bow type and age division that coordinate with shooter scorecard color.
- 4. Ties will be broken on the number of twelves.

Class Options:

- Bare Bow (longbow or recurve) may NOT be equipped with sights or sighting marks, kisser buttons, peeps sites or cushion plungers or mechanical release aids; may have added weights but MUST be in compliance with USA shooting rules
- 2. Compound Aided may be equipped with magnified sights & stabilizers, mechanical releases are permitted
- 3. **Compound Unaided** may NOT be equipped with magnified sights or stabilizers or mechanical releases; may be equipped with single pin or multiple pin sights
- 4. **Genesis** original Genesis bows (NO mini's or Pro's) with no sights or sighting marks and no stabilizers, no mechanical releases; ONLY Easton 1820 30" arrows are allowed

Safety and Range Rules: In addition to Safety and Range Rules listed above . . .

- 1. NO range finders on the course.
- 2. Participants must remain at your target until the group ahead of you completely leaves their target. Then you may advance.
- 3. Adults are to remain behind the shooting line at all times.
- 4. If you have questions or need assistance, DIV 4-H Archery Committee members will be spread out along the course.
- 5. Arrows will be removed by a participant 15 years old or older that is on their squad for all participants under the age of 13
- 6. During arrow pulling, participants will remain at least five (5) feet back from both the target and the person pulling the arrows.
- 7. Designated District IV 4-H Archery Committee members will assist shooters with scoring, pulling arrows, etc.

Pistol Rules - Non-Qualifying Contest

Note: to be in compliance with the U.S. BATF regulations, ALL pistol shooters under the age of 18 MUST have in their possession a written permission statement providing the parent or legal guardian permission to possess ammunition and a handgun as well as fire the handgun. A simple written statement of permission will suffice including name of shooter, parent/legal guardian name, signature and address and signature of witness, dated on the day and year of signature. This permission is valid for one year after signature date. A sample is provided in this memo. **Failure to have this form will disqualify the competitor.**

Pistol: any small-bore pistol or revolver firing the .22 rimfire long rifle, long or short cartridges, with a sight radius no greater than 10 inches (10"), minimum barrel length allowed on all pistols and revolvers is four inches (4") equipped with iron sights ONLY (sights that require the user to align a front and rear sight on the target). NO telescopic or optical sights, i.e., NO laser, red dot, holographic or prism sights. NO sight that projects an image on the target.

Target: NRA B-8

Distance: 50 feet

Course of Fire: no sighter shots

Juniors: 10 shots slow (10 minutes)

10 shots timed (2 rounds of 5 shots; 20 seconds each) 10 shots timed (2 rounds of 5 shots; 20 seconds each)

Intermediates & Seniors: 10 shots slow (10 minutes)

10 shots timed (2 rounds of 5 shots; 20 seconds each) 10 shots rapid (2 rounds of 5 shots; 10 seconds each)

Positions: Junior – sitting using maximum of 2 sandbags on the table with only the butt of the pistol & hands touching the bags in a 2-handed supported position, the barrel may not be touching any support

Intermediate - 2 hands standing

Seniors – 1 hand standing

Smallbore Rifle Rules – State Qualifying Contest for Senior Age Division Shooters

Members Per Team: Teams consist of three (3) or four (4) members of the same age division. Junior members are allowed to move up to the intermediate age division in order to complete a team but will solely compete in that age division. Juniors and Intermediates are not allowed to move up to senior age division.

Senior age division is a state qualifying competition. Top three (3) teams and top three (3) individuals qualify for State Indoor Rifle Match. May 31-June 2, 2025

Rifle: any SAFE .22 rifle chambered for .22 long rifle cartridges capable of single loading may be used. NO semi-automatic or pump action rifles may be used in this match. NO stocks based on the AR15/M16 platform to include Ruger 10/22 or any other action in the AR stock. NO folding or collapsible stocks. The same rifle must be used through the match except in the case of a malfunction or a disabled rifle. NO barrel devices.

Sights: Open or aperture sights ONLY – metallic or equivalent material may be used in this match. NO sights that require a battery or that project an image on the target or telescopic sights are allowed at this match. Spotting scopes are allowed.

Distance: 50 feet using NRA A-36 target (or comparable target)

Shooting Classifications and Options:

- JUNIORS -
 - Prone ONLY individuals will shoot prone only. Juniors will shoot two (2) targets in the prone position ONLY for a total of twenty (20) record shots. Juniors may shoot as an individual or on a team of three (3) or four (4) members. 20 minutes running time. NO 3P for Junior age division.
- INTERMEDIATES 3P (3 position). Intermediates may shoot as an individual or as a three (3) or four (4) member team. One (1) target prone, one (1) target standing and one (1) target kneeling will be shot for a total of thirty (30) recorded shots. 45 minutes running time.
- SENIORS 3P (3 position). Intermediates may shoot as an individual or as a three (3) or four (3) member team. One (1) target prone, one (1) target standing and one (1) target kneeling will be shot for a total of thirty (30) recorded shots. 45 minutes running time.
- CHALLENGES <u>ONLY</u> the shooter will be allowed to review targets and challenge a score. The shooter will have fifteen (15) minutes following the completion of scoring of their relay to review and challenge scores. The shooter must put up a \$1 pre hole being challenged. IF score is upheld, the shooter donates their \$1 to District IV 4-H Shooting Sports and will be given a receipt for their donation. IF the score is corrected, the shooter will receive their \$1 back. See state rules for scoring procedures.
- TIES- broken on the number of bullseyes.

NEW Sporter Air Rifle Rules – Non-Qualifying Contest

The sporter air rifle is intended to be a low cost, entry-level rifle without specialized modifications.

Members Per Team: Teams consist of three (3) or four (4) members of the same age division. Junior members are allowed to move up to the intermediate age division in order to complete a team but will solely compete in that age division. Juniors and Intermediates are not allowed to move up to senior age division.

Rifle: any SAFE type .177 (4.5mm) pneumatic, spring air, compressed air or CO₂ rifle may be used if it has conventional appearance. NO stocks based on the AR15/M16 platform to include Ruger 10/22 or any other action in the AR stock. NO folding or collapsible stocks. The same rifle must be used through the match except in the case of a malfunction or a disabled rifle. NO barrel devices.

Sights: Open or aperture sights ONLY – metallic or equivalent material may be used in this match. NO sights that require a battery or that project an image on the target or telescopic sights are allowed at this match. Spotting scopes are allowed.

Distance: 33 feet using NRA A-36 target (or comparable target)

NOT allowed:

Shooting jackets or trousers, pads, braces or elastic bandages, gloves or competition shoes; ONLY normal street type or light athletic shoes are allowed; a maximum of two (2) unaltered sweatshirts may be worn during firing.

Shooting Classifications and Options:

- JUNIORS -
 - Prone ONLY individuals will shoot prone only. Juniors will shoot two (2) targets in the prone position ONLY for a total of twenty (20) record shots. Juniors may shoot as an individual or on a team of three (3) or four (4) members. 20 minutes running time. NO 3P for Junior age division.
- INTERMEDIATES 3P (3 position). Intermediates may shoot as an individual or as a three (3) or four (4) member team. One (1) target prone, one (1) target standing and one (1) target kneeling will be shot for a total of thirty (30) recorded shots. 45 minutes running time.
- SENIORS 3P (3 position). Intermediates may shoot as an individual or as a three (3) or four (4) member team. One (1) target prone, one (1) target standing and one (1) target kneeling will be shot for a total of thirty (30) recorded shots. 45 minutes running time.
- CHALLENGES <u>ONLY</u> the shooter will be allowed to review targets and challenge a score. The
 shooter will have fifteen (15) minutes following the completion of scoring of their relay to review and
 challenge scores. The shooter must put up a \$1 pre hole being challenged. IF score is upheld, the
 shooter donates their \$1 to District IV 4-H Shooting Sports and will be given a receipt for their
 donation. IF the score is corrected, the shooter will receive their \$1 back. See state rules for scoring
 procedures.
- TIES- broken on the number of bullseyes.

Shotgun Rules - Non-Qualifying Contest

Squadding – Counties MUST list preferred squads at entry (participants will list squad members at entry). Participants that are not squadded at entry will be squadded by match officials by county and age divisions as best as possible.

Equipment: 12-gauge or smaller shotgun must be used. 7½ shot size or smaller is required (example – 8, 9)

Course of Fire:

Both rounds of skeet and/or both trap may be shot on the same skeet and trap fields.

- 1. Skeet two (2) rounds of twenty-five (25) targets for a total of fifty (50) targets
- 2. Trap two (2) rounds of twenty-five (25) targets for a total of fifty (50) targets
- 3. Ties broken by shoot-off up to third place.

Shoot-Off:

A shoot-off/tie breaker for 1st and 2nd places only

- For skeet one (1) round of twenty-five (25) targets until tie is broken
- For trap one (1) round of twenty-five (25) targets until tie is broken

- 1. EXCULPATORY CLAUSE. In consideration for receiving permission to participate in any and all activities of Texas 4-H ("activity"), which is sponsored by Texas A&M AgriLife Extension Service and Texas 4-H Youth Development Program, ("sponsor"), a member of The Texas A&M University System, I hereby release, waive, covenant not to sue, and agree to hold harmless for any and all purposes sponsor, The Texas A&M University System, the Board of Regents for The Texas A&M University System, and their members, officers, agents, volunteers, or employees ("RELEASEES" or "INDEMNITEES") from any and all liabilities, claims, demands, injuries (including death), or damages, including court costs and attorney's fees and expenses, that may be sustained by me while participating in this activity, while traveling to and from the activity, or while on the premises owned, leased, or controlled by RELEASEES, including injuries sustained as a result of the sole, joint, or concurrent negligence, gross negligence, negligence per se, statutory fault, intentional torts, or strict liability of RELEASEES.
- 2. INDEMNITY CLAUSE. I am fully aware that there are inherent risks to myself and others involved with this activity, including but not limited to all events and activities, and I choose to voluntarily participate in this activity with full knowledge that the activity may be hazardous to me and my property, and to the person and property of others. I acknowledge there may be physically strenuous activities. I know of no medical reason why I should not participate. Lagree to indemnify and hold harmless INDEMNITEES from any and all liabilities, claims, demands, injuries (including death), or damages, including court costs and attorney's fees and expenses, which may occur to myself, other participants, and third-persons as a result of my participation and conduct in this activity, including injuries sustained as a result of the sole, joint, or concurrent negligence, gross negligence, negligence per se, statutory fault, intentional torts, or strict liability of INDEMNITEES.
- 3. COVID-19. I expressly acknowledge the health risks and dangers associated with the transmission of the COVID-19 virus, and other communicable diseases, and recognize that exposure to the COVID-19 virus, or other communicable diseases, could occur while my child is in the care of sponsor. As such, and as additional consideration for participation in the activity, I understand the waiver and indemnity provisions in paragraphs (1) and (2) above apply to the possibility of COVID-19 community spread. Sponsor does not carry general liability insurance to cover claims arising from this activity so it seeks a waiver of claims as additional consideration for the right to participate so sponsor, a governmental unit of the State of Texas, can(a) provide the activity at the lowest possible cost to participants; and (b) provide access to a greater number of participants by expending limited resources on program materials rather than on liability insurance.
- 5. BINDS HEIRS. It is my express intent that this agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representatives, if I am deceased, and shall be governed by the laws of the State of Texas.
- 6. MEDICAL AUTHORIZATION, INDEMNITY FOR MEDICAL EXPENSES, and WAIVER. I understand RELEASEES cannot be expected to control all of the risks associated with this activity and RELEASEES may need to respond to accidents and potential emergency situations.
